
8 5/8" 24 # casing set at 389'. Cemented with 325 sx cement. Cement circulated.

5 1/2" 14# casing set at 2198'. Cemented with 535 sx cement. Cement circulated.

Perforations: 1810'-2002'

1. MIRU and POOH with production equipment.
2. Make gauge ring run and set 5 1/2" CIBP at 1710'. Circulate MLF and test casing to 500#.
3. Spot 50 sx cement on top of CIBP.
4. Spot cement from 439' to surface.
5. Cut off wellhead 3' below ground level.
6. Install upright marker and cut off anchors.
