Additional Comments: Closure work plan for drilling pit. Category 2 location: The drilling pit contents will be excavated from the pit area.
If there is evidence of contamination, the soil will be tested by lab and if contamination is confirmed, further remediation will be conducted according to guidelines. A trench will be installed. The trench will be lined with a 12-mil impervious liner and the excavated material will be placed on top. The trench will then be encapsulated with 20-mil liner. The excavated pit will be backfilled with clean soil and the pit area as well as the trench will be covered and contoured with three feet of soil or like material capable of supporting native plant growth to prevent erosion and ponding of rainwater.
A one call and a 48 hour notice will be provided to the Oil Conservation Division.

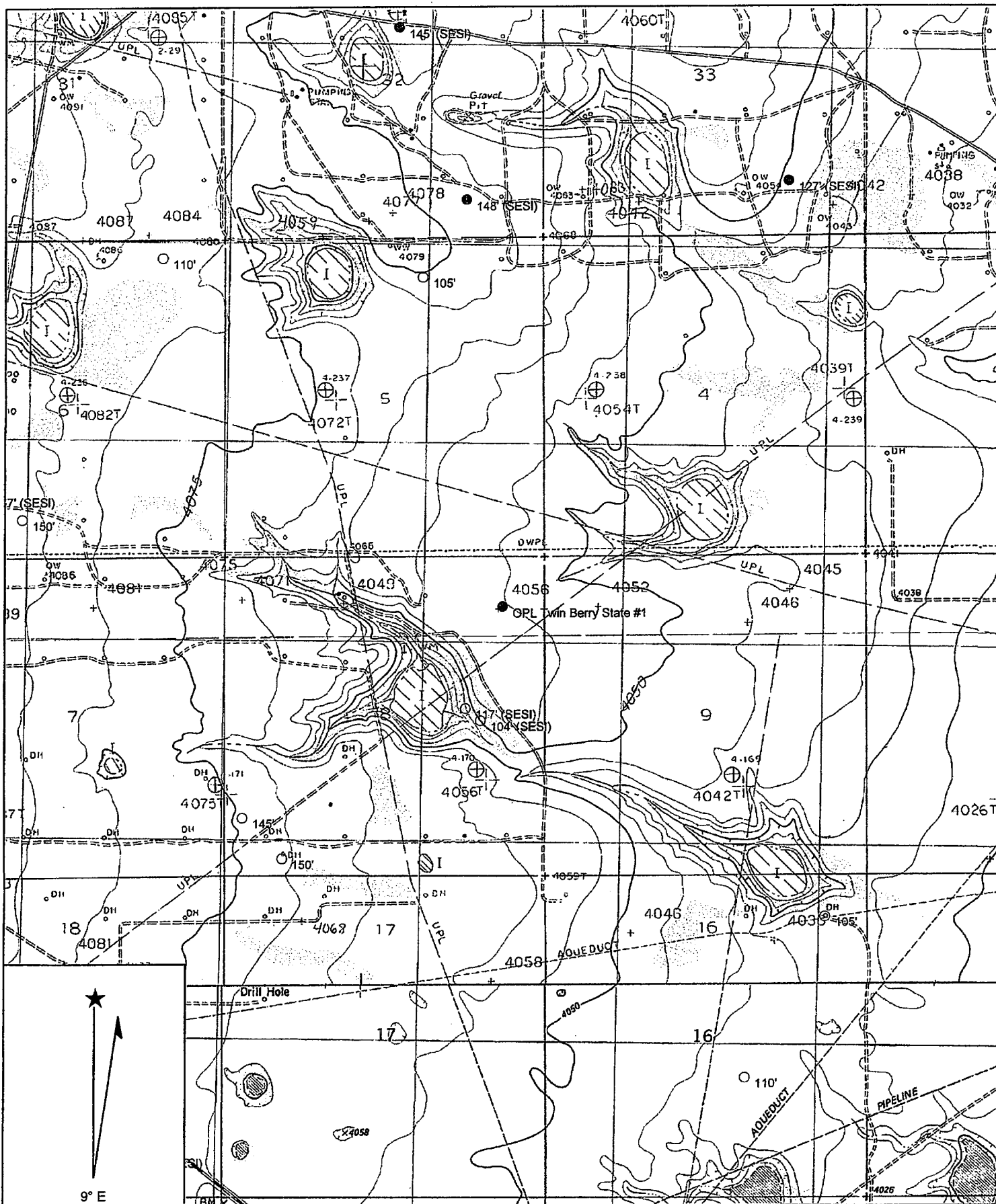
