On 12/15/2018, Enstor conducted pre-workover diagnostics on Grama Ridge GRM Unit #8 Well which included pressure testing the tubing / casing annulus per MIT testing guidelines and also pressure testing the injection / withdrawal tubing to confirm integrity. Both tests were successful and were witnessed and approved by John Staton, Petroleum Engineer Technician with the BLM. NMOCD Field Office was contacted also; however, no representative was available to witness the test.

On 12/17/2018, George Bower (NMOCD Compliance Officer) verbally approved successful MIT of the GRMU #8 Well and informed Enstor to proceed with submittal of Subsequent Sundry Report.

Based on successful MIT, Enstor requests removal of the Shut-in Directive issued on 6/21/17 so that the well may be placed back into active service.
