Matador has previously forwarded your office a copy of the sundry approved by the Bureau of Land Management regarding the Leslie Fed Com #215H (API No. 30-025-44546), approving the change in well location as reflected on the enclosed C102. Because the completed interval is now closer than 330 feet to the eastern boundary line of the spacing unit, I write to inform you that the W/2W/2 of Section 17 and the E/2W/2 of Section 17 have uniform interests as to the mineral estate in the objective formation and therefore the setback requirements do not apply to the eastern boundary of the spacing unit under NMAC 19.15.16.15(C)(7).
