Tail w/200 sks Class C w/0.15% retarder. Mixed @ 14.8#/g w/1.32 yd. Plug down @ 1:15 PM 12/18/18. Set ECP w/1750#. Drop bomb & open DV tool w/600#. Circ 10 sks of cmt off DV tool. Cemented 2nd stage lead w/800 sks Lite Class C (50:50:10) w/additives. Mixed @ 11.5 #/g w/2.70 yd. Tail w/200 sks Class C w/0.15% retarder. Mixed @ 14.8#/g w/1.32 yd. Plug down @ 5:45 PM 12/18/18.
