

- 11/23/18: Pressure test casing to 9800 psi for 30 minutes.
- 12/3/18 - 12/13/18: Perforate from 10,575' - 15,401' (1380). Acidize with 46,000 gallons 15% HCl. Frac with 11,360,050 lbs sand and 11,151,210 gal fluid.
- 12/15/18 - 12/16/18: Drill all plugs out and clean out to 15,415'.
- 12/30/18 - Set packer at 10,300'. Run 2-7/8" production tubing and gas lift valves *set @ 10,300'*
- 12/31/18: Begin flowback


