Ms. Hovey:

The application submitted on behalf of 3Bear Field Services LLC for approval of the Grama 34 State SWD No. 1 is being denied. This denial is based on the location of the proposed well within the Grama Ridge Storage Area. This unit is a gas storage unit utilizing the Morrow Formation as the storage reservoir. The storage area is described in Order No. R-13174 (Case No. 14332) as:

The current operator of the facility is Enstor Grama Ridge Storage and Transportation.

The Division denies this application based on recent observations of a higher frequency by operators of Devonian SWD with completions showing poor cementing of liners and/or casings across the Pennsylvanian section. In light of the events at the Aliso Canyon Gas Storage Facility, the Division is not willing to accept the potential for the compromise of the reservoir seal which could result in waste as well as impacts to correlative rights and the environment. Additionally, if 3Bear Field Services LLC wishes to pursue a hearing in this matter, the Division shall appear in opposition of this application.

For future reference, there is a second gas storage unit in Eddy County. This is the Washington Ranch Storage Project which is southwest of White City. This gas storage project also utilizes the Morrow for the storage reservoir and is currently operated by El Paso Natural Gas Co. This gas storage unit was approved under Division Order No. R-6175 as amended and includes the following lands:

The location of this facility has shown limited interest for disposal applications, but this may change in the future.

And, for good measure, I will mention Project Gnome of the Plowshare Program that resides in Section 34 of T23S, R30E, NMPM, but entry is not possible since the section is under the authority of the DOE through an administrative withdrawal order issued by the BLM.
