On 01/31/19 Legacy Reserves received permission fr/the BLM (Jonathon Shepard) to set a CIBP @ 9,350' w/50' cmt on top in place of the original request of 9,500' w/50' cmt on top. This became necessary when the depth of 9.500' could not be reached due to casing issues. The remainder of the procedure stays the same and is as follows:

- Perforate, acidize & test Delaware zones from ~7,000'-8,050'
- Return well to production in Delaware Zone
