Operator:

Under the provisions of NMOCD Rule 19.15.26.10. (A), an operator of an INJECTION or SWD well or producing well in a specially designated area, must maintain and periodically test these wells for mechanical integrity.

Your company currently has wells (listed in attachment) which are due for testing during the 2019 calendar year.
