ConocoPhillips Company respectfully intends this well to be governed by the horizontal well rules currently in effect. The well has been drilled, but not completed. As noted in the amended C-102 which is attached, the 100' setback requirement at the heel and toe of the horizontal section will be applied for first take point and last take point.

Completion operations are expected to begin as early as April 17, 2019. Per NMED guidance, this can serve as OOOOa notification.
