ConocoPhillips Company respectfully requests approval to change the original APD for this well and add a second access road north of the existing one. The disturbance will be a standard 30' width and about 15' long. This area is expected to be approximately 0.010 acres.

This additional road will provide safer turnaround for trucks hauling production from the facility. One road will be for entering the facility, while the other will be for exiting.

The attached diagram provides a depiction of where a second access road will be positioned.

We request that this be considered for approval under an amendment to the previous EA or under CE due to limited additional surface use.
