- E. This exception is requested for the following reasons: Request approval to flare royalty free during
facility start-up and bringing new wells on production. Intermittent flaring may extend past that
allowed in 19.15.18.12 for up to 90 days. Expected flared volumes will likely not exceed 620 mcf/well/day.
