**Plugging Report
Artesia Metex Unit

5/27/2019 Cleared location with backhoe and tested anchors. Moved in rig and rigged up. Repaired casing stub by welding old wellhead from the #46 on it. Installed BOP. Moved in workstring and remaining equipment. RIH with workstring to 1365' and SION.

5/28/2019 Moved in remaining equipment. Spot 50 sx cement with CaCl at 1365'. WOC and tagged cement at 1239'. Pumped MLF. No fluid to surface. POOH with tubing and remove BOP. Dumped 3 yards gravel. Tagged with tubing at 992'. Dumped 2.7 yards gravel. Tagged at 774'. Dumped 2.7 yards gravel. Tagged at 564'. Installed BOP and caught circulation with 5 bbls. Lost circulation after 2 more bbls. Spot 25 sx cement with CaCl at 564'. POOH and SION.

5/29/2019 Tagged cement at 512'. Well would not circulate. Spot 25 sx cement with CaCl at 512'. WOC and tagged cement at 425'. Pumped 30 bbls to get circulation. Last 5 bbls had a trickle to the pit. Spot 50 sx cement with CaCl. Laid down remaining pipe and rigged down. SION

5/30/2019 Filled up 8 5/8" casing from the top with 65 sx cement. Cut off wellhead and installed marker. Cut off anchors and cleared the location.
