CONDITIONS OF APPROVAL

XTO ENERGY INC

MISS AMIGOS STATE # 106H

- 1) SURFACE & INTERMEDIATE CASING - Cement must circulate to surface --
- 2) PRODUCTION CASING - Cement must tie back into intermediate casing --
- 3) If cement does not circulate to surface, must run temperature survey or other log to determine top of cement
- 4) Surface casing must be set 25' below top of Rustler Anhydrite in order to seal off protectable water
- 5) Will require a directional survey with the C-104
- 6) The Operator is to notify NMOCD by sundry (Form C-103) within ten (10) days of the well being
- 7) Drilling Sundries Form C-103 (Casing and Cement test are to be submitted within 10 days
- 8) Completion Reports & Logs are to be submitted within 45 days
- 9) Deviation / Directional Drill Survey are to be filed with or prior to C-104
- 10) It is the operator's responsibility to monitor cancellation dates of approved APDs. APD's are good for 2 years and may be extended for one year. Only one 1 year extension will be granted if submitted by C-103 before expiration date. After expiration date or after a 1 year extension must submit new APD.
- 11) When using Stage Tools
 - a) Must notify OCD Hobbs Office prior to running Stage Tool at 5753703186
 - b) If using Stage Tool on Surface casing, Stage Tool must be set greater than 350' from surface and a minimum of 200 feet above surface shoe.
 - c) When using a Stage Tool on Intermediate or Production Casing Stage must be a minimum of 50 feet below previous casing shoe.
