Requesting approval for surface disturbance to address the remediation of the site (amended C141 sent to NMOCD & BLM on 6/20/2019). As the release borders a lease road, Devon does not foresee the need of a buffer of more than five feet around the edges of the excavation to access and remediate the site.

Estimated start date: July 8, 2019

The release area will be excavated to the NMOCD Closure Criteria, the top four (4) feet of impacted areas off the well pad will be excavated and backfilled meeting the Reclamation requirement of 19.15.29.13(D)(1). SMA will guide the excavation by collecting composite soil samples for field screening for chloride using an EC meter. Approximately 4600 cubic yards of contaminated soil are projected to be removed and replaced with clean backfill material in order to return the surface to previous contours.




