Survey from 2017 did not find a brass cap and the footage calls were calculated by surveyor. Subsequent to the original C-102, the brass cap was located. Longitude and Latitudes did not change, however surface footage calls are revised based on discovered brass cap (i.e. a boundary change). The physical surface location did not move.
