7/9/2019 Prepare to clean out well. Acidize w/450 gals 15% HCL w/ additives. Avg rate 2 BPM @ 1500#. Flush w/95 BBLs produced water. Avg rate 2 BPM @ 1,000#, SITP 1,000#. RDMO, Shut well in for 2 hours to let the acid work. Turn SWD back on, clean location, TOTP.
