Surface Cement: Pressure tested lines to 3,000 psi. Pumped 20 bbls of gelled spacer followed by 10 bbls of fresh water with dye. Pumped 270 bbls of cement (1150sks) @ 14.8 ppg (1.32 cuft/sk, Class C w/ 0.125 lb/sk LCM Fiber). Dropped latch-in top plug and began displacement. Pumped 155 bbls of fresh water. Bumped plug on time with a final lift pressure of 500 psi. Pressured up to 1,000 psi, held for 2 minutes and bled back 0.5 bbls. Floats Held. There were good returns throughout the job and we circulated approx. 100 bbls (425 sks) of cement to surface.
