Cotton Draw Yeti Pad

Chevron USA Inc respectfully requests authorization to add 2-Pipelines to an existing ROW that was permitted as part of the Cotton Draw Yeti APD. There would be no changes to the ROW, just the contents of the ROW.

Justification: The original ROW contents for the Cotton Draw Yeti Pad included liquid and gas pipelines that were undersized and would lead to significantly constrained production. In order to fully produce the wells from the Cotton Draw Yeti Pad, it's being proposed that a 12" gas gathering pipeline (9,932.63' total length) & a 12" liquid gathering pipeline (9,917.22') be included in the previously permitted ROW.
