Casing: Ran 5.5" 23# RYS P110 to 22,446'

Cement: Pressure tested lines to 8,000 psi. Pumped 60 bbls of Tuned Spacer III @ 11.8 ppg w/ 0.125 lb/sk flake. Pumped 185 bbls of lead cement (495 sks) @ 11.7 ppg (2.1 cuft/sk, "NeoCem"). Pumped 211 bbls of tail cement (970 sks) @ 14.5 ppg (1.22 cuft/sk, 50:50:2-Poz:ClassH:Gel w/ 0.4% Fluid Loss + 0.3% Retarder) followed by 5 bbls of sugar water. Shut down, washed pump, dropped latch-in top plug and began displacement. Pumped 30 bbls of sugar water followed by 445 bbls of fresh water. Bumped plug on time with a final lift pressure of 4,000 psi. Pressured up to 4,500 psi, held for 2 minutes and bled back ~7 bbls to the truck, floats held. There were good returns throughout the job. 60 bbls of spacer and 3 bbls cement was circulated to surface.
