

- 10/23/2019: MIRU. Unseat pump and L/D rods.
- 10/24/2019: Continue to L/D rods. N/U BOPE. Unable to find free point and release tool. Kerry Fortner(NMOCD) gave permission to cut pipe.
- 10/25/2019: Cut 2 3/8 TBG at 8906'. Set CIBP at 8580'.
- 10/26/2019: Tag CIBP at 8580'. Pressure test casing to 500 PSI for 15 minutes - good. Spot 35 SKS Class H 15.8 PPG. Perforate at 6840'. Unable to establish injection rate. Drop below perfs and spot 35 SKS Class C 14.8 PPG.
- 10/27/2019: Tag TOC at 6433'. Perforate at 3450'. Unable to establish injection rate. Drop below perfs and spot 40 SKS Class C 14.8 PPG. WOC. Tag TOC at 3112'. Perforate at 2100'. Unable to establish injection rate.
- 10/28/2019: Tag TOC at 1912'. Perforate at 458'. Attempt to establish injection rate between intermediate and surface - unable to establish around surface casing. Spot 120 SKS Class C 14.8 PPG - verified cement to surface. RDMO.
