

Trinity Oilfield Services & Rentals, LLC (Trinity) has been contracted by OXY USA, Inc. (OXY), to perform soil remediation activities following hydrocarbon and produced water releases along an array of poly flow lines in the pasture between the WBR Federal Battery and the WBR Federal 0005 well site. The releases affected areas of the pasture measuring approximately 2,900 square feet (WBR Federal 0001 flow line release) and 970 square feet (WBR Federal 0005 flow line release). A hand auger and/or backhoe will be utilized to collect a series of soil samples to investigate the vertical and horizontal extent of impacted soil at both release sites. The dimensions of the excavations will be based on these soil samples. A backhoe will be utilized to excavate the impacted material, and a front-end loader will be utilized to transfer the excavated material to the WBR Federal 0005 well pad to be stockpiled on 6-mil plastic, pending transfer to a nearby disposal facility. The WBR Federal 0005 well pad will also be used as the staging area for all remediation activities, as well as for stockpiling of clean material to be used as backfill.

To minimize damage to extant native vegetation and non-impacted local topography, only the existing 2-track dirt road connecting the WBR Federal Battery and the WBR Federal 0005 well site will be used to access the release sites.
