Cotton Draw Yeti Pad

Chevron USA Inc respectfully requests authorization to add a 20' x 59.88' access road to the entrance of the Cotton Draw Yeti pad.

Justification: The Chevron Completions team recently completed a review of their safety procedures during well completions and identified as a gap the lack of 2-access roads. In the event of an emergency requiring evacuation, the single access road restricts traffic and limits the pace in which the evacuation can occur. The 2nd access road allows for egress in the event of an emergency for the Completions Team and will be reclaimed after the Pad's wells have been completed.






