ConocoPhillips Company respectfully requests acceptance of this report of an undesirable event, which is below reportable quantities, but migrated into small area off pad. This release was the subject of 19MH142W. The location was scheduled for remediation before your visit on 7/11/19 and was mostly remediated before the notice was received.

Per our discussion on September 18th, the following official notice is provided.
On January 3, 2019 a produced water and oil fluid release occurred. The release was below reportable quantity, approximately 2 bbls. Contamination was excavated and clean material was used to backfill the location, using backhoe and excavation equipment. Your drawing reflects the impacted area which was remediated. Access to the off-pad area was via the pipeline right of way adjacent to the well location.
