Mixed @ 14.8#/g w/1.33 yd. Displaced w/292 bbls FW. Plug down @ 5:30 PM 11/21/19. Circ 308 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 6:30 P.M. 11/22/19, tested csg to 1500# for 30 mins, held OK. FIT to 10.5 PPG EMW. Drilled out with 12 1/4" bit.
