Devon Energy respectfully requests the following procedure to plug and abandon set conductor:

1. Pump cement job to completely fill conductor with cement
2. Cut off casing 55" below GL
3. Weld plate to cutoff casing. Plate needs to include the following information:
 - a. Company name, Well Name and Number, API Number, & Legal Description
4. Take GPS measurement of plate location
 - a. Can be taken with a hand-help GPS (does not need to be certified or done by a surveying company)
 - b. Take picture of GPS coordinate and plate
 - i. Send to engineer to be stored in well file for this well
5. GPS coordinate information / picture will be given to regulatory to file with C-103 (plug and abandon report)
 - a. Upon completion of drilling / completion, regulatory will file C-103, NMOCD will inspect location, bond on well will be released
6. Fill cellar with caliche
7. Get post job cement report from cement vendor
