Production Cement: Pressure tested lines to 7,100 psi. Pumped 60 bbls of Weighted Spacer @ 11.5 ppg. Pumped 210 bbls of lead cement (400 sks) @ 11.4 ppg (2.95 cuft/sk, 50:50:12-Poz:ClassH:Gel w/ 5% Salt + 0.5% Suspension Aid + 0.6% Retarder + 0.4% Anti Settling + 0.4lb/sk Defoamer). Pumped 213 bbls of tail cement (1000 sks) @ 14.5 ppg (1.24 cuft/sk, 50:50:2-Poz:ClassH:Gel w/ 0.4% Fluid Loss + 0.55% Retarder + 0.15% Anti Settling) followed by 5 bbls of sugar water. Shut down, washed pump, dropped latch-in top plug and began displacement. Pumped 20 bbls of sugar water followed by 457 bbls of fresh water. Did not bump! Final lift pressure was 5,100 psi @ 1.5 bpm. A pressure spike happened around 465 bbls into displacement. Casing was shut in at the cement head. Circulated ~ 100
