WOC 8 hrs. Test 9-5/8" casing to 2700psi for 30 min, good test. TIH & drill new formation to 6594', perform FIT test to EMW=10.5ppg, good test. 12/11/19 drill 8-1/2" hole to 9208' and perform bradenhead squeeze on 12-1/4" by 9-5/8" annulus. Pump 1024sx (310bbls) w/ additives 12.8 ppg 1.70 yield, with cement visual from surface, WOC for 9.5 hrs.
