Apache is requesting permission to add Drinkard pay and acidize, as follows:

1. RIH w/ bit and drill through cement and CIBP from 5,561' to 5,603'.
2. Tag cement at 7,014'. POOH.
3. RIH w/ bit and scraper to CIBP at 7,014.
4. RIH w/ wireline and perforate ~80' of Drinkard pay from 6,625' to 6,775'.
5. RIH w/ work string and 5-1/2" treating packer. Acidize Drinkard interval with 10,000 gals of 15% HCl. POOH.
6. RIH w/ 2-7/8" production tubing and set at SN at ~6,810'.
7. RIH w/ pump and rods.
8. Return well to production.
