Hi Amanda,

I need your help on one last issue with the disconnection and retirement of the power lines for this meter. In order for the NMOCD to close the site, the inspector is asking for a written confirmation that the poles and wire belonging to the Cooperative will be removed.

It has become a more important issue, because the NMOCD is holding up issuance of a drilling permit for a well until the Buckeye location is properly documented as closing and being in progress for the final restoration – which includes the future removal of the power lines.

I would appreciate your help in forwarding this request to Ray or whomever might be able to help me with this. I can give any assurance needed to make sure that the Cooperative will be able to bill BTA for the costs that they are supposed to cover for this future work.

Again, I appreciate your help. A note from the Cooperative that I can forward to the NMOCD will take care of the site closing for the Buckeye SWD.
