### **Conditions of Approval for Change of Operator**

1. Tank battery must be bermed/diked (must be able to contain 1 1/2 times the volume of the largest tank).
2. If changes have been made to the previously approved water disposal method, submit a new water disposal method via Sundry Notice (Form 3160-5) within 60 days of approval of this sundry.
3. Review facility diagrams on file and submit updated facility diagrams within 60 days of approval of this sundry (Onshore Order #3).
4. The Bureau of Land Management shall be notified of any spill or discharge (575-234-6235) as required by NTL-3A.
5. All outstanding environmental issues must be addressed within 90 days of approval of this sundry. Contact Jim Amos at 575-234-5909 for inspection and to resolve environmental issues.
6. Install a legible well sign on location with the operator's name, well name and number, lease number, unit number, 1/4 1/4, section, township, and range (NMOCD requires the API number on well signs).
7. Subject to like approval by New Mexico Oil Conservation Division.
8. All reporting to ONRR (OGOR Reports) must be brought current within 30 days of approval of this sundry.
9. If this well is incapable of producing in paying quantities, submit a Sundry Notice (Form 3160-5) to plug and abandon this well within 90 days of approval of this sundry.
10. Submit a plan for approval of well operations for a TA/SI well within 30 days of approval of this sundry.
11. If not in place, acquire operating rights on this lease within 30 days of approval of this sundry with the Bureau of Land Management state office in Santa Fe, NM.
