COG Operating, LLC. respectfully requests authorization to construct, operate, maintain, and reclaim a 4-inch surface poly gas pipeline in the SE1/4NE1/4 and E1/2SE1/4 of section 11, T26S., R. 35E. The surface gas pipeline will go from the tie-in point at the northeast corner of an unknown location, south following the existing oilfield lease road, to the Tatanka Federal No. 4H location. The pipeline will be 3,283.4 ft. (0.62 mile) in length, 30 ft. in width for a surface disturbance of 2.26 acres.

The Archaeological survey has been conducted and submitted to the BLM Archaeological Department.
