OXY USA Inc. (OXY) is submitting this list of associated wells and API numbers for West Dollarhide Devonian Unit Battery, as an attachment to Form C-129, Application for Exception to No-Flare Rule 19.15.18.12.

Currently, we are venting at this site. Nearest mid-stream as system is Energy Transfer and at this time, Energy Transfer's pipeline line is unable to take all the gas we send, as their gas pipeline has a pressure restriction, which our current production rate causes their line pressure to exceed their restrictions. Energy Transfer has a valve that hold our sales rate down to the line pressure they set, so therefore, OXY vents the excess gas.
