1. Each CMS shall meet the requirements of **43 CFR 3174.9 CMS - general requirements and components**.
2. Record beginning totalizer readings prior to the first load of oil being sold through each meter.
3. Each CMS shall be proven during its first load of oil transferred from this facility.
4. A run ticket for each oil transfer shall be produced and, if used for reporting oil sold to ONRR, shall contain the information listed in **43 CFR 3174.12(b)(1)**.
5. Operator shall maintain detailed pumpers' logs including estimated daily production and those items listed in **43 CFR 3173.9 Required recordkeeping**.
6. Records described above shall be maintained for a period of six years from the date of generation and made available for audit upon request.
7. This agency reserves the right to modify or rescind approval whenever it determines continued use of the approved method may adversely affect measurement or reporting.
