2/10/20 thru 2/15/20: RIH w/tbg and set CIBP @ 3470'. Pull up 1 jt. then load csg. and test to 500 psig for 30 min. with no leak off. POOH, RIH w/tbg to 3465' and spot 40 sx Class C cement. POOH w/8 jts tbg. WOC. RIH and tag cement @ 3200'. Pull tbg. to 3100' and spot 40 sx Class C cement. POOH w/tbg, RIH w/wireline and tag cement @ 2825'. Pull up to 1620' and shoot csg. w/4 holes. Pump into hole @1620' w/8 bbls @1700 psig. Call OCD for procedure. RIH w/tbg and spot 25 sx of Class C cement across perfs. POOH w/tbg. RIH w/wireline and tag cement at 1500'. NU to backside of 7' csg. and broke circulation to surface on 9 5/8" then pump 14.8# cement, 19 bbls slurry, 79 sx @230 psig. NDBOP, top off both strings of surface. Cut off wellhead. Install dead hole marker and back fill, dig up deadman and dress up location.
