Additional Comments : Work plan for closure pit. Pit contents will be mixed with earthen material to stiffen pit contents. Encapsulation trench will be constructed and lined with a 12 mil synthetic liner. Pit contents will be placed in a lined trench. A 20 mil synthetic liner will then be placed over the pit contents with a 3' over lap of the under lying Pit area. The capping liner will then have a minimum of 3' of topsoil placed on top. A 48 hour notice will be provided to the Oil Conservation Division before pit closure actions are begun.
