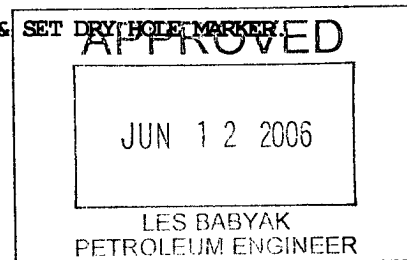

- 5) MIX & PUMP A 10 SX. CMT. SURF. PLUG @ 63'-3'.
- 6) DIG OUT & CUT OFF WELLHEAD 3' B.G.L.; WELD STEEL PLATE ON CASINGS & SET DRY HOLE MARKER.
