RU pump trk & circ 96 BW & pkr fluid. Set pkr w/12 pts tension. ND BO & NU WH. Press test to 500 psi for 30 mins (lost 5 psi on chart). RD Key & turn well to inj @ 4:45 PM. Attempt 4x's to get pkr to seal @ 4137' failed, pull up 1 jt to 4104' & reset.
