3.) RU WIRELINE. PERFORATE 2 HOLES @ 2215' AND 2 HOLES @ 475'. RD WIRELINE.

Squeeze perts @ 2700' + 100' plug inside 4 1/2" csg.

4.) RIH WITH TBG AND PACKER. SET PACKER @ 2200' AND SQUEEZE WITH 80 SACKS CLASS "C" NEAT CEMENT. (AS PER DAVID GLASS, BLM 6/5/03). TAG PLUG.

5.) PU, SET PACKER @ 460', SQUEEZE WITH 25 SACKS CEMENT. FLUSH TO PACKER. UNSEAT PACKER. SPOT 25 SACKS CEMENT.

6.) PULL UP TO 250' & REVERSE. POOH WITH PACKER. TAG CEMENT PLUG. POOH. SET 10 SACKS TO SURFACE PLUG.
