4.) RIH WITH TBG AND PACKER. SET PACKER @ 2180' AND SQUEEZE WITH 80 SACKS CLASS "C" NEAT CEMENT. (AS PER DAVID GLASS, BLM 6/5/03). TAG PLUG.

5.) PU, SET PACKER @ 420', SQUEEZE WITH 25 SACKS CEMENT. FLUSH TO PACKER. UNSEAT PACKER. SPOT 25 SACKS CEMENT.

6.) PULL UP TO 250' &amp; REVERSE. POOH WITH PACKER. TAG CEMENT PLUG. POOH. SET 10 SACKS TO SURFACE PLUG.
