DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 132 joints of 8 5/8" 32# J-55 (new) casing to 3807 feet. Cemented using two stage cementing tool at 1562'. Cemented with 250 sacks at bottom of casing and with 150 sacks at 1562'. Released pressure after 40 hours, pumped 500# pressure into casing, held for 15 minutes.
