A casing liner was set in this well by the following procedures.

Ran 115 joints of 4 1/2" 11.6 # casing and set at 3590'.
Cemented casing with 350 sacks of class H cement. WOC
24 hrs. Temperature survey indicates top of cement at 600'.
Tested casing for 30 minutes with 1,000 # pressure. Tested O.K.
Drilled out cement from 3200' to 3560' and cleaned out to 3728'.
Re-ran producing equipment and placed well on production
