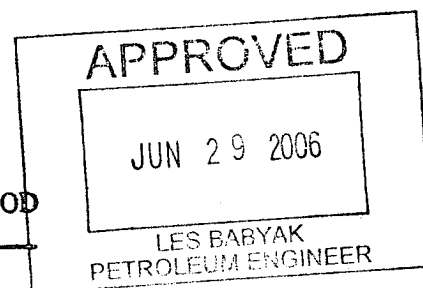

3. Pull out of hole with production tubing and BHA.
4. RIH with bit and cleanout to below bottom perf @7724'.
5. Stimulate with acid perf zone 7116' - 7724'.
6. Swab load back.
7. Run back in hole with production tubing and BHA.
8. Run back in hole with pump and rods.
9. Return well to production.
