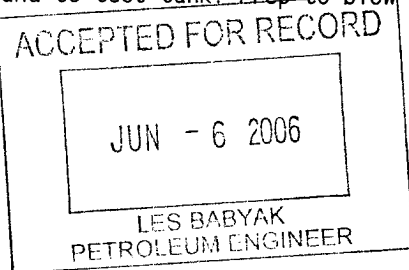

The 15' KB corrected EOT is the bottom of the orifice valve @ 11,347'. valve #2 is @ 10,823', valve #3 is @ 9806', valve #4 is @ 8479', and valve #5 is @ 6817'. ND the BOP, NU 2-7/8" X 1900" Larkin wellhead. RD pump truck. SI the well, SDFWE. Will try to kick the well off ASAP.  
5/10 & 5/11/06 - Move in test tank and build wellhead to sales and to test tank. Prep to blow well down  
5/13/06 & 5/18/06 - Flow testing to test tank.
