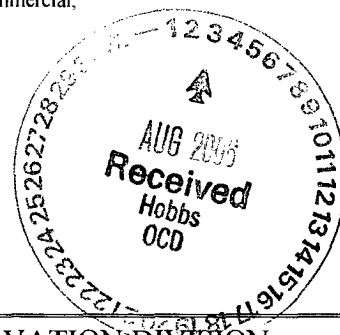

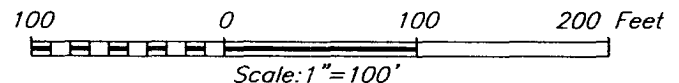

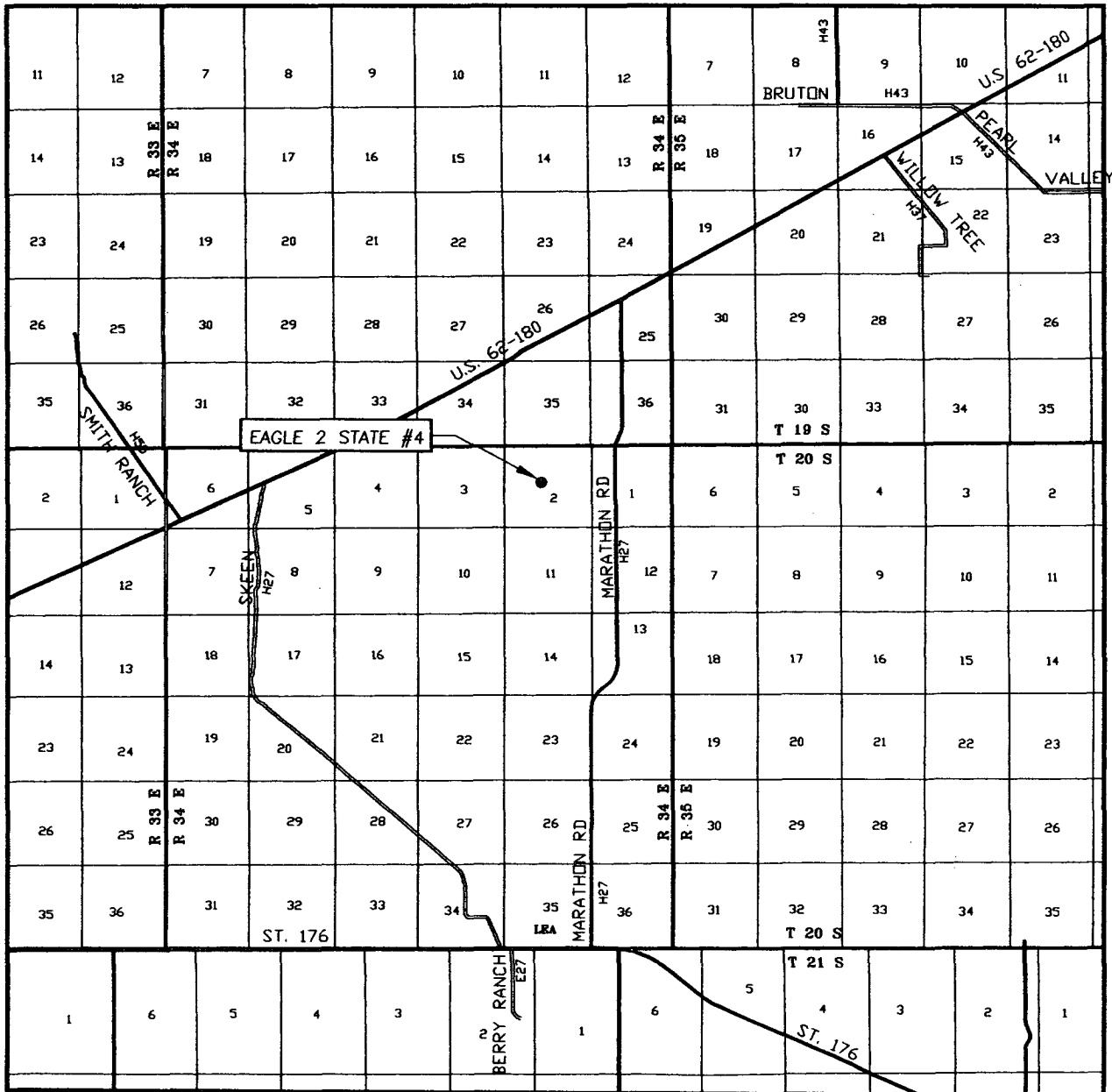
EAGLE 2 STATE #4

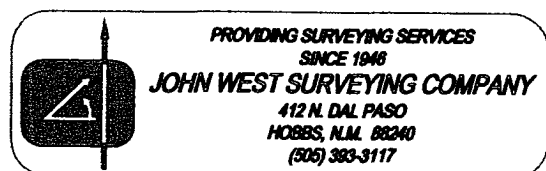

VICINITY MAP

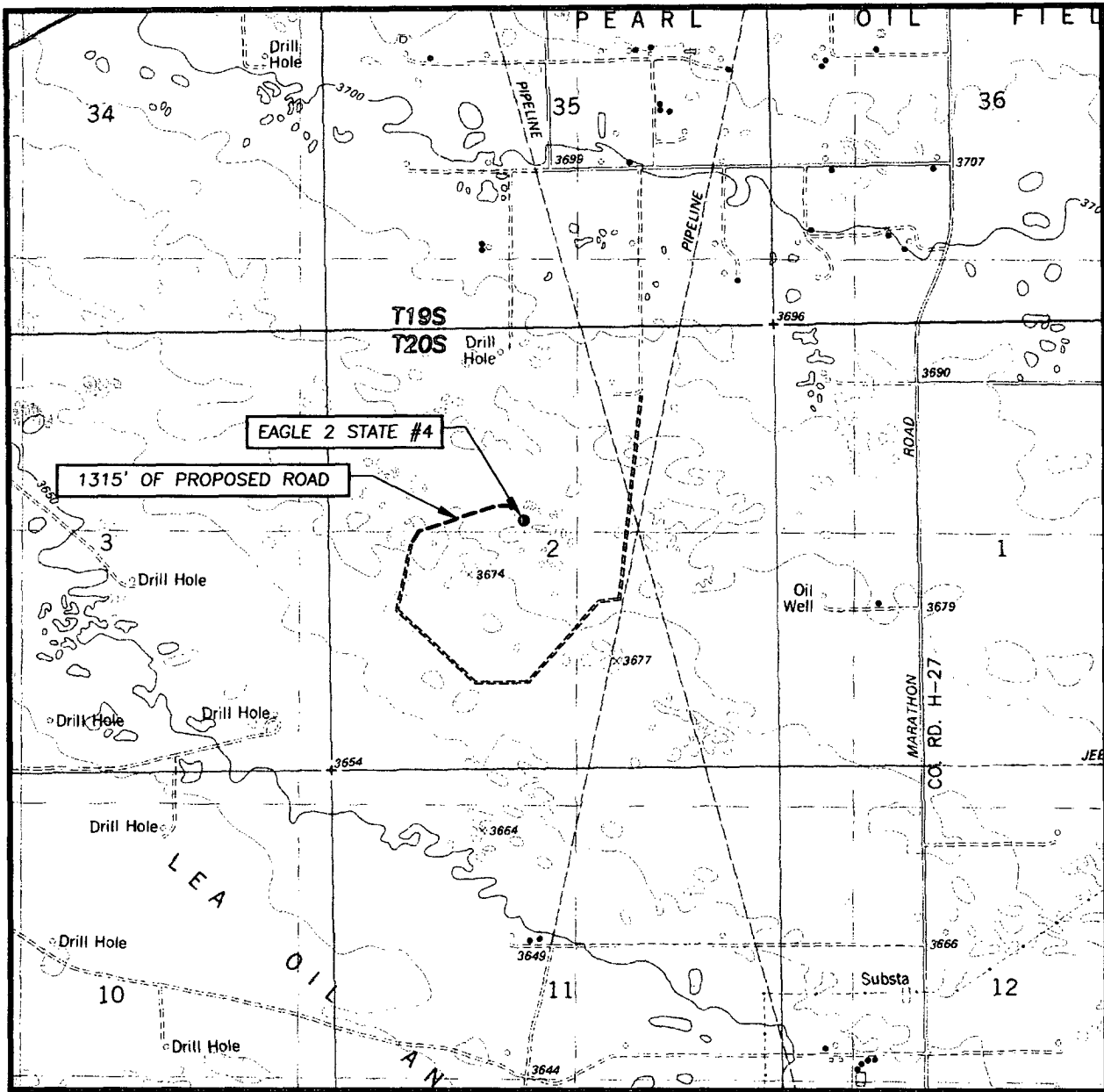
