RU WL and perf 4220' - 4230', 2 JSPF (22 holes). Acidize perf'd interval at 4164' - 4240' with 1260 gal. 15% NEFE acid. RU swab equipment and flow back acid. RIH with 4.5" G-6 packer on 128 jts. of 2-7/8" duo-line injection tubing (packer set at 4062'). Circulate hole with 100 bbls 10# packer fluid. ND BOP x NU WH. Test casing to 680 psi x 30 minutes (held). RD x MO. Clean location and put well back on injection.
