8-24-06 Circulated plugging mud. Spotted 30 sx plug @ 4471'. WOC and tagged @ 4136'. Perforated @ 2100'. Tested casing to 1000#. Set tubing @ 2151' and spotted 25 sx plug in casing.

8-25-06 Tagged @ 1872'. Perforated @ 527'. Tested and held 1000#. Spotted 25 sx plug @ 586'. WOC and tagged @ 333'. Spotted 10 sx 96' to surface. Cleaned location and installed dry-hole marker.
