Tail with 200 sks Class C with 2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Circ 90 sks to pit. WOC 18 hrs. At 3:30 am on 07/25/06, test BOPE and 13 3/8" casing to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.

07/28/06...TD'ed 12 1/4" hole @ 2471'. Ran 2471' 8 5/8" 32# J55 ST&C Csg. Cemented with 600 sks BJ Lite Class C (35:65:6) with additives. Mixed @ 12.5 #/g w/ 1.98 yd. Tail with 400 sks Class C Neat. Mixed @ 14.8 #/g w/ 1.33 yd. Circ 98 sks to pit. WOC 18 hrs. Test BOPE to 3000# and annular to 1500#, held OK. At 3:30 pm 07/28/06, tested 8 5/8" csg to 1500# for 30 mins, held OK. Charts and schematic attached. Drilled out with 7 7/8" bit.

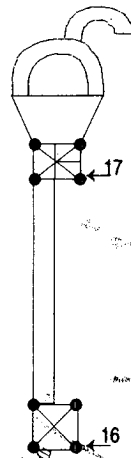

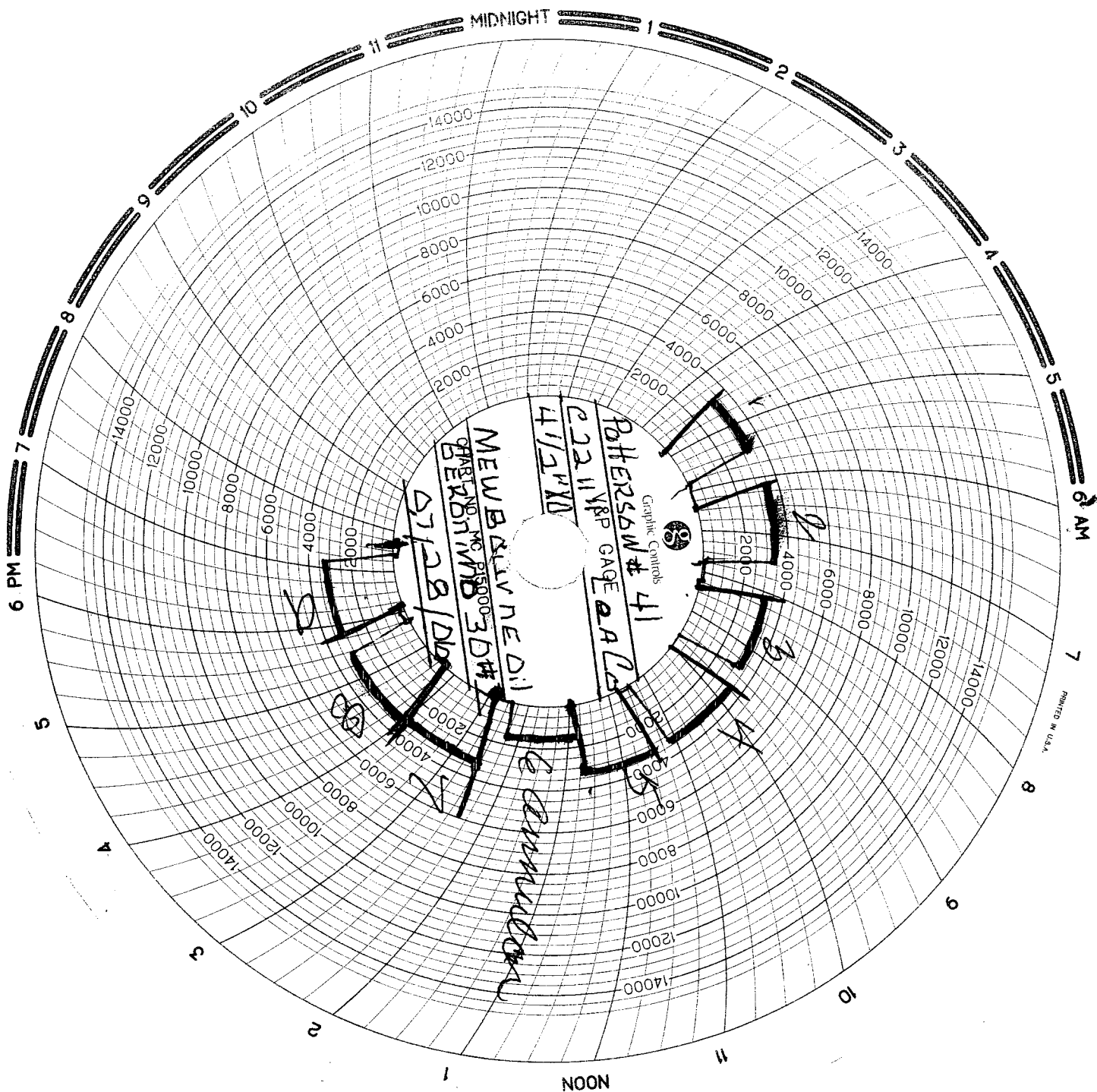
