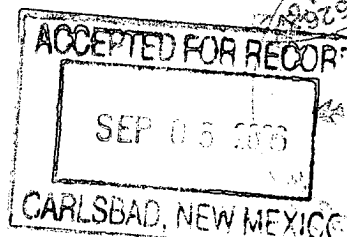

Mixed @ 12.5 /g w/1.94 yd. Tail with 250 sks Class H cement with additives. Mixed @ 15.1 #/g w/ 1.28 yd.
Lift pressure at 1623# at 3.5 BPM. At 7:00 am 08/10/06, tested 5 1/2" casing to 2267# for 30 mins, held OK. Set 100k on slips.

08/11/06...Released rig at 12:01 pm 08/10/06.

08/19/06...Ran CBL and found TOC at 1486'.
