Henry Petroleum had been very active the past year (2005) returning wells to production in the unit (4 wells) and the non unit (2 wells) and was already busy doing the same this year. Henry Petroleum has transferred operatorship to Legacy Reserves - effective 8-1-2006. Legacy is accelerating the schedule for remedial work and would like permission to keep this well TA'd for now and evaluate the well to return to production as each phase is completed. The phases are currently under way.
